THEY SERVE MEDICAL RECIPIENTS AND OFFER SLIDING SCALE FEES FOR THOSE WITHOUT INSURANCE. 97% OF THEIR PATIENTS ARE AT OR BELOW THE FEDERAL POVERTY LEVEL. THEY PROVIDE ACCESS TO DENTAL EDUCATION AND AFFORDABLE TREATMENT IN ORDER TO IMPROVE THE ORAL HEALTH OF THE COMMUNITY.
